I wanted to give you an update on our well. We have removed most of the equipment from the site and will continue with excavating work to improve the site. Going forward we will have a fenced area around the well head. The well head itself is secured with temporary plugs and valves. Our security employees will visit the location on a regular basis.

We were able to do some preliminary work on the well (Aug. 21) and are shutting down at 5:30. Tomorrow morning (Aug. 22) we will run an electronic log and begin the process of swabbing the well and testing the lower most zone in the well. We may not have results by the end of the day tomorrow, but we are making progress in that direction.

We have moved a truck mounted completion rig to the site. This rig is approximately 2/3 the height of the drilling rig. The completion rig only operates during daylight hours as opposed to the 24 hour activity of the drilling rig. I anticipate this smaller rig to be on location for approximately two weeks. At the end of this time we will know whether or not the we have a productive well. Should the well be productive the rig will leave and the site will be restored and landscaped. We are completing the removal of the drilling rig today (Aug. 19), and still anticipate moving a completion rig in tomorrow (Aug. 20) to begin testing the well. The completion rig works only during daylight hours. We should have definitive results on the well within 30 days.

West Bay is still on track to remove the drilling rig from the site on Tuesday (Aug. 19). We anticipate moving a smaller, truck mounted rig in on Wednesday to begin the completion. This smaller rig, approximately 2/3 the height of the drilling rig, will only operate during daytime hours. While the results of the well are inconclusive, we would hope to have better information by the end of the week. Should the well prove productive, we will temporarily cap the well and begin working on a pipeline, in the existing pipeline corridor, to remove product from the site and transport it to a processing facility some distance away in a commercial/industrial location. The only thing then left on the drilling location will be a small garden shed sized building and the well head itself which is approximately fifteen feet tall. This area will be landscaped to fit into the surrounding lots. There will be a berm, fence and vegetation similar to landscaped yards in the community to keep the well from view. The only activity on that site will be a pickup truck visiting twice a day to check on the well. West Bay also maintains remote monitoring so that field personnel have access to well data 24 hours a day.

### West Bay Exploration commits to industrial site if production site is necessary

Shelby Township Supervisor Rick Stathakis has obtained written confirmation from West Bay Exploration, the oil company drilling near 25 Mile and Dequindre roads, that any production facilities associated with wells in Shelby Township will be located in an industrial area.

Currently, West Bay Exploration is in the process of assessing what if any deposits are available at the well that was completed this week. Continue reading for the full statement from West Bay Exploration:

"West Bay has completed the drilling phase of our well in Shelby Township. Our geologists and engineers are currently analyzing the results of that drilling to try and determine whether or not we have discovered hydrocarbons.

Should we determine that we have made a discovery we will begin the completion phase. At that point activity will be limited to day light hours, and the rig is a much smaller truck mounted rig.

West Bay has been drilling and producing wells in Shelby Twp. for almost thirty years. During that time we have paid individual landowners more than \$13 million dollars in royalty. We specialize in operating in highly urbanized areas and fitting our operation into the community with little impact. The drilling phase which we just completed is the most visible of our activities.

If we are successful and move into a production phase there will be no impact on the neighborhood. A pickup truck will visit the well head twice a day. The well site itself will be landscaped in such a way as to blend into the surrounding environment. Production equipment and processing activities will take place some distance away in a commercial/industrial area.

No one is more concerned about safety and environmental issues than I. West Bay goes above and beyond DEQ regulations to ensure that the environment and the public are protected. These DEQ regulations are some of the most stringent in the country and ensure that our activity is safe no matter where it is located. West Bay is proposing to host a workshop in the Township next week where will make our staff geologist, engineers, geophysicist, and executives available to speak with residents one on one."

# West Bay Exploration confirms pipeline use for product transportation

Shelby Township Supervisor Rick Stathakis received written confirmation from West Bay Exploration officials Aug. 12 that a pipeline will be used to transport any product from a well near 25 Mile and Dequindre roads to a processing facility that will be in an industrial or commercial zone. The use of a pipeline will minimize the amount of heavy truck traffic to and from the well site if oil/gas is found. Read more for West Bay Exploration's full statement:

"Oil would be transported via pipeline to a facility somewhere along the existing Consumers Power right of way on the northern edge of our well pad. This could be 3-4 miles away. Our first step is to make a well. We would then look for the appropriate facility location in a commercial/industrial area."
