**RESOLUTION APPROVING ADMINISTRATIVE FEES PURSUANT TO THE
CHARTER TOWNSHIP OF SHELBY CODE OF ORDINANCE - REGULATIONS
AND LICENSING OF DONATION BOXES WITHIN THE TOWNSHIP**

Resolution made and adopted at a Regular Meeting of the Board of Trustees of the Charter Township of Shelby, Macomb County, Michigan, held in the Municipal Building, 52700 Van Dyke Avenue, Shelby Township, MI 48316-3572, on the 20th day of September, 2022 at 7:00 p.m.

WHEREAS, the Charter Township of Shelby passed a Code of Ordinance Amendment to allow to license, regulate and impose conditions on all donation boxes within the Township. The Ordinance Amendment provides that no person shall place, operate, maintain or allow any donation box on any real property without first obtaining an annual permit and that the Board of Trustees shall set an administrative fee and a renewal fee for same by Resolution.

NOW, THEREFORE, Be It Resolved by the Board of Trustees of Shelby Township as follows:

1. Pursuant to Sections 10-353 and 10-355 of the Code of Ordinances the following fees shall apply to donation boxes located within the Township:
 - a. Application Fee (non-refundable) for a single donation box located on a single lot of record or parcel: \$300.00
 - b. Application fee (non-refundable) for multiple donation boxes located on a single lot of record or parcel \$ 300.00 for the first donation box and \$50.00 for each additional
 - c. Replacement stickers: \$25.00
 - d. Annual renewal fee for a single donation box located on a single lot of record or parcel: \$150.00

- e. Annual renewal fee for multiple donation boxes located on a single lot of record or parcel \$150.00 for the first donation box and \$ 25.00 for each additional
