## Priority Waste customers can recycle yard waste with curbside collection until Dec. 13

For 2024, yard waste collection ends Dec. 13. Yard waste consists of leaves, lawn cuttings, shrubs and tree trimmings. Priority Waste residential customers should place yard waste into the designated brown containers, paper biodegradable bags or labeled containers up to 35 gallons in size.

Priority Waste enforces yard waste weight limits. Brush and limbs less than 2 inches in diameter must be in bundles no longer than 4 feet and not exceeding a total of 18 inches

in diameter or more than 50 pounds. Branches exceeding 2 inches in diameter cannot be collected by Priority Waste. Dirt, sod, large stumps, sand, gravel, concrete, rocks, animal feces and dead animals are not considered yard waste.

Yard waste containing plastic containers, potters, mulch bags or other plastic is considered contaminated and will be disposed of in regular trash. Please remove all plastic bags, ties and pieces from yard waste before placing on the curb.

Management of customer service for Shelby Township with Priority Waste is overseen by the township's Department of Public Works, Solid Waste and Recycling Committee and the Supervisor's Office.

If you've already paid your annual bill but received an invoice from Priority Waste, please email billing@prioritywaste.com with your name, address and payment details. Priority Waste will update your account and confirm your payment in writing. Please note, it may take up to a week for confirmation.

#### **Trash Tips for Priority Waste Customers**

- Yard waste begins the first week of April and ends the second week in December.
- Cardboard boxes need to be flattened and put in your recycling bin or bound and placed next to your container.
- Mattresses and box springs must be wrapped in plastic before you put them curbside.
- Large items can be placed curbside on your pickup day.
- Place all trash at the curb by 7 a.m. or the night before your pickup day.
- Priority Waste observed holidays: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Day.

## Honor military, first reponders at township's Patriot Day, Veterans Day services

To honor those who protect the community at home and the soldiers that paid the ultimate sacrifice abroad, Shelby Township hosts its Patriot Day Prayer Service at 1:30 p.m. on Sept. 11 at the township's Veterans Memorial.

Veterans Event Coordinator Phil Randazzo, a Vietnam veteran whose honors include two Purple Hearts and two Bronze Stars for valor, and the Shelby Township Police and Fire departments host the event.

The service allows the community to recognize its first responders and pay respects to Mark Barbret, Tarryl Hill, Christopher Kube, D. Alex Knapp, Todd Lambka and Kyle McClain, the six residents who died from injuries sustained while serving in the U.S. military in Iraq and Afghanistan as part of the Global War on Terror.

Officials from the Shelby Township Police Department and Shelby Township Fire Department will lead the Pledge of Allegiance and place a wreath at the township's memorial. The event closes with a brief prayer service.

The township will also celebrate its Veterans Day Ceremony coordinated by Randazzo. The Veterans Day Ceremony will feature patriotic music performances, speeches and a prayer. Nov. 10 at the Veterans Memorial at 52700 Van Dyke Ave.

"The Memorial Day Ceremony is an occasion to remember and honor our fallen soldiers," said Randazzo. "And, on Veterans Day, we celebrate the men and women who served our nation and were blessed enough to make it back home to their families and friends."

The Treasurer's Office issued Summer tax statements on July 1, payable without penalty until Sept. 16. After Sept. 16, a 1% late fee is assessed for September. An additional 1% will be assessed the first of each month, thereafter, through February of the following year. We'd like to remind residents that personal wipes, paper towels and other materials should not be flushed down toilets. Only toilet paper should be flushed down pipes.

#### Make sure your property is up to code this fall

Sidewalk-Property owners are responsible for maintaining safe conditions for sidewalks adjacent to their property, which includes a property's sidewalks in front, and if applicable on the side, and behind the house. According to Township ordinance Section 58-528, sidewalks must be clear from obstructions such as low-hanging branches, shrubs or bushes that protrude into and over the sidewalk. Trim obstructions behind the edge of the sidewalk and branches need to be trimmed high enough to allow a bicyclist to pass underneath.

Firewood-Firewood is permitted on residential lots for personal home heating purposes only. Township ordinance Section 3.35 requires that firewood be neatly stacked. While not required, firewood should be raised off the ground to prevent animals from nesting under it. The sale of firewood is prohibited.

Trash-All trash, recyclable materials and residential yard waste must be gathered, stored and placed in a closed container or containers sufficient in size and number to store the waste. Under Township ordinance Section 62-6(6), place containers at the curb after 5:30 p.m. the day before pick up and remove by 8 p.m. the day of pick up. For large amounts of waste, order a dumpster through a waste hauler. Place large items at the curb on your regular collection day. Mattress and/or box springs placed at the curb must be wrapped in plastic for pick up. Please wrap each item separately and entirely, overlapping, as necessary.

Sales-Garage, yard, estate or similar-type sales do not require a permit. Only two sales are allowed in a 12-month period at one location, and each sale can only last four or fewer days. Sale signs are only allowed on the property of the sale and other private property with the consent of the property owner. Signs shall not be attached to utility poles or trees and cannot encroach the road right-of-way, typically the area between a sidewalk and street. Immediately remove all signs following the sale.

**Signs**-Signs shall not be attached to any utility poles or trees and cannot encroach into any road rightof-way, typically between a sidewalk and street. Property owners must approve all sign placements on a property.

Trash dumpsters—Dumpsters are limited to a period not to exceed 14 days on single-family residential property. These containers shall be located in the driveway and not in any public road or right-of-way.



#### What is your alarm telling you?

#### **SMOKE ALARMS**

- A continued set of three loud beeps—beep, beep, beep—means smoke or fire. Get out, call **9-1-1**, and stay out.
- A single "chirp" every 30 or 60 seconds means the battery is low and must be changed.
- All smoke alarms must be replaced after 10 years.
- Chirping that continues after the battery has been replaced means the alarm is at the end of its life and the unit must be replaced.

#### **CARBON MONOXIDE (CO) ALARMS**

- A continuous set of four loud beeps—beep, beep, beep, beep—means carbon monoxide is present in your home. Go outside, call 9-1-1 and stay out.
- A single chirp every 30 or 60 seconds means the battery is low and must be replaced.
- CO alarms also have "end of life" sounds that vary by manufacturer. This means it's time to get a new CO alarm.
- Chirping that continues after the battery has been replaced means the alarm is at the end of its life and the unit must be replaced.

### Floodplain Information

**FLOOD HAZARD AREAS** — Portions of Shelby Township are encumbered by the 100-year floodplain. The areas most susceptible to flooding are along the main and middle branch of the Clinton River. Smaller floodplain areas exist proximate to the Harris, Longstaff, Decker, Dunn and Bannister Drains. Of course, any drain, stream, river or other body of water in the township poses a flooding risk.

Find out if your property is in the regulated 100-year floodplain and additional information on floodway, Historical Flooding and Wetland by calling the Shelby Township Floodplain Management Office at 586-731-5969 or by visiting the Building Department. The township keeps records of elevation certificates for public view. Maps can also be reviewed online at **fema.gov** or by visiting the Building Department.

**FLOOD SAFETY** — Here are some things you can do to protect your family and property from flooding.

- Contact your property insurance agent to see if a flood insurance policy would help you. Even if you're not in the mapped floodplain, you may be subject to flooding from local drainage. In either case, flood insurance can be a good investment because most homeowner insurance policies do not cover damage caused by surface water flooding.
- Do not walk or drive through flood water. Currents are deceptive; just six inches of moving water can knock you off your feet. Do not drive around barriers, as the road or bridge may be washed out.
- Stay away from power lines and electrical wires. If your house is about to be flooded, turn off the power at the service box. Electrical current can travel through water. Electrocution is the second leading cause of death during floods.
- Be alert to gas leaks. Turn off the gas to your house before it floods. If you smell gas, report it to a township official or your gas company. Do not use candles, lanterns or open flames if you smell gas or are unsure if your gas has been shut off.
- Keep children away from the flood waters, ditches, culverts and storm drains. Flood waters can carry unknown items that have dislodged themselves. Culverts may suck smaller people into them rendering them helpless.
- Clean everything that has been wet. Flood water will be contaminated with sewage and other chemicals which pose severe health threats.
- Look out for animals, especially snakes. Small animals that have been flooded out of their home may seek shelter in yours.
- Do not use gas engines, such as generators, or charcoal fires indoors during power outages. Carbonmonoxide exhaust can pose serious health hazards.

**PROPERTY PROTECTION MEASURES** — Talk to us about protecting your house or business.

There are ways to modify your building to minimize flood damage. Where flooding is shallow, measures such as small flood-walls, regarding the yard, and flood-proofing the walls or utilities can be relatively inexpensive. Where flooding is deep, a building may need to be elevated.

Check with the Shelby Township Building Department before you build, alter, regrade or fill on your property. Call 586-731-5969 first. A permit may be needed to ensure that a project is compliant with all regulations. These regulations are designed to protect your property from flood damage and to make sure you do not cause a water problem for your neighbors.

#### **FLOODPLAIN PERMIT**

**REQUIREMENTS** — All development within the 100-year floodplain (including construction of buildings, filling, excavation, fences, etc.) is required to obtain a permit from the Shelby Township Building Department. Other state and local permits may be applicable too. Applications must be made prior to doing any work in a floodplain area. Please contact the Building Department to receive all the information you will need in order to properly develop in the floodplain at 586-731-5969. You may report any unlawful development activities to the above number as well.

SUBSTANTIAL IMPROVEMENT/ **DAMAGE** — For buildings within regulated floodplains, the National Flood Insurance Program requires that, if the cost of improvements to a building or the cost to repair damages (from any cause) exceeds 50 percent of the market value of the building (excluding land value), the entire building must be brought up to current floodplain management standards. Building improvement projects include exterior and interior remodeling, rehabilitation, additions, and repair and reconstruction projects. Please contact the Shelby Township Building Department at

586-731-5969 for details.

FLOOD INSURANCE — If you do not have flood insurance, talk to your insurance agent. Most homeowner's insurance policies do not cover damage from floods. Flood insurance is only available to participating communities in the National Flood Insurance Program (NFIP), such as Shelby Township. Our commitment to floodplain management helps to minimize flood hazards and enables us to be a part of the NFIP. Additionally, because Shelby Township participates in the Federal **Emergency Management Agency's** Community Rating System program, flood insurance premiums are discounted.

Be sure to check your policy to ensure you have adequate coverage. Usually these policies cover the building structure, but not the contents. Contents coverage can also be obtained by asking. There is a 30-day waiting period before flood insurance coverage becomes effective. Plan ahead; do not wait until a flood is predicted before purchasing flood insurance.

If you are building within a floodplain, the purchase of flood insurance is mandatory if using a federally regulated/insured bank for a loan.

**NATURAL & BENEFICIAL** FUNCTIONS — Don't pour oil, grease, pesticides, or other pollutants down storm drains or into the ditches and streams. Our streams and wetlands help moderate flooding and are habitat for fish, frogs, and other species that provide us with recreation or food. Let's protect them and their homes. Floodplains play a valuable role in providing natural and beneficial functions to the area around, and including, Shelby Township. Floodplains that are relatively undisturbed provide a wide range of benefits to both human and natural systems. These benefits provide aesthetic pleasure as well as function to provide active processes such as filtering nutrients. Significant areas in Shelby Township's River Bends and Holland Ponds parks are located within the floodplain associated with the Clinton River. Both enhance waterfowl, fish and other wildlife habitats and provide feeding/breeding grounds. Lastly, such floodplain areas provide natural erosion control and open space so further flooding damage does not occur.

#### **DRAINAGE SYSTEM MAINTENANCE**

— As simple as it may sound, keeping smaller ditches and streams free of debris dramatically improves run-off capacity in low-lying areas and greatly reduces the occurrence blockage that significantly contributes to flooding. It is illegal to dump materials into a required waterway and violators may be fined. If you see someone in the act of dumping in one of our watercourses, please report it to the Shelby Township Building Department at 586-731-5969 or the Macomb County Public Works Offices at 586-469-5327.
